

AS9120 is for stockists and distributors of parts to manufacturers that supply the aerospace industry. This standard addresses the chain of custody, traceability, stock control and availability of records.




### IATF 16949

IATF 16949 emphasises the development of a process-oriented quality management system that provides for: continual improvement, defect prevention, reduction of variation and waste in the supply chain specifically in the automotive industry. The goal is to meet customer requirements efficiently and effectively.

# INFORMATION SECURITY



### ISO 27001

This standard provides a framework for Information Security Management Systems (ISMS) that enables the continued accessibility, confidentiality and integrity of information as well as legal compliance.

### ISO 20000-1

This standard is designed to help organisations deliver effective managed IT services to customers and maintain those standards over time. It helps organisations efficiently deliver quality IT Service Management through a comprehensive process approach.

#### ISO 27701

This standard provides guidance for organisations looking to support compliance with GDPR and other data privacy requirements. It's a great way of demonstrating to customers, external stakeholders and internal stakeholders that effective systems are in place to support compliance to GDPR and other privacy legislations.

### ISO 27017

This standard is an extension and provides additional security controls for cloud service providers and for cloud service customers.

### ISO 27018

ISO 27018 is for the protection of personally identifiable information: a code of practice for cloud service providers who process this data for their customers.

An organisaton implementing these extensions would select the relevant controls for their individual circumstances.

### ISO 22000

ISO 22000 combines and supplements the core elements of ISO 9001 and HACCP to provide an effective framework for the development, implementation, monitorisation and continual improvement of a documented Food Safety Management System (FSMS) within the context of the organisation's overall business risks.

#### **GMP**

GMP (Good Manufacturing Practices) establishes the operational conditions and requirements necessary to ensure hygiene throughout the food chain and for the production thereof.

### FSSC 22000

Food Safety System Certification has been developed in response to customer demands for a recognisable standard against which a food safety management system can be audited and certificated.

### HACCP

Hazard Analysis and Critical Control Points (HACCP) is the most internationally recognised system based on production of safe food from a preventative approach. A HACCP-based system is a legal requirement in several countries, including USA and UAE, at all levels of the food chain, with the exception of primary production.

Developed by Energy & Utility Skills, CMS enables operators to demonstrate technical competent management of their permitted activities. It can be used in any industry for the management of their environment permit, as required by the Environmental Permitting (England and Wales) Regulations 2016 and in Scotland, by the Environmental Protection Act 1990.


