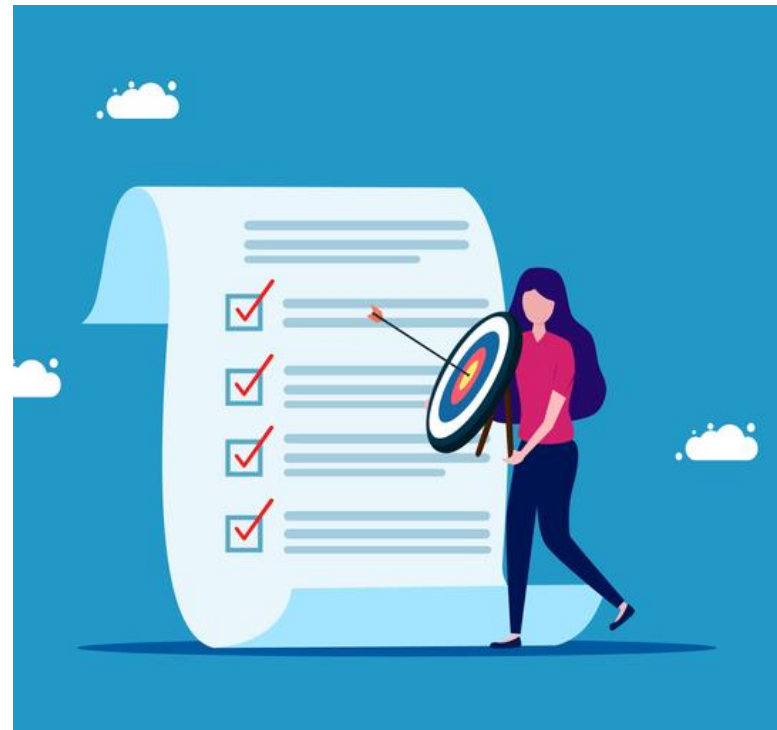

- **Acquisition**

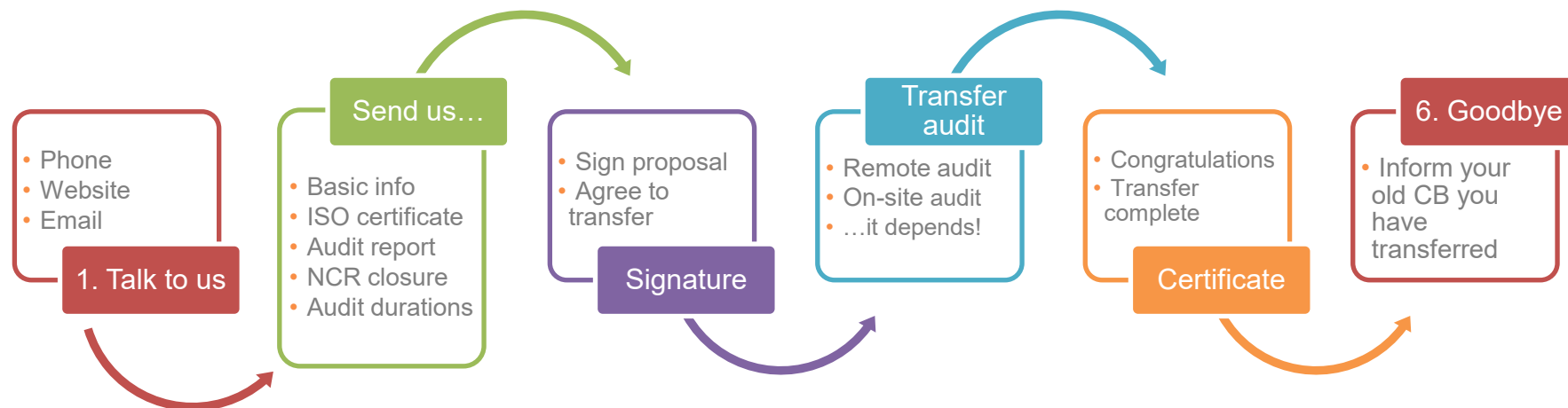

There are just 6 simple steps:

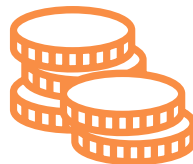


TRANSFERRING TO NQA: TIME & COST
