The verification has been shared as positive news online and offline across the business. Unicorn Group has seen a renewed commitment to their sustainability goals, with team members more focused on the environment than ever.

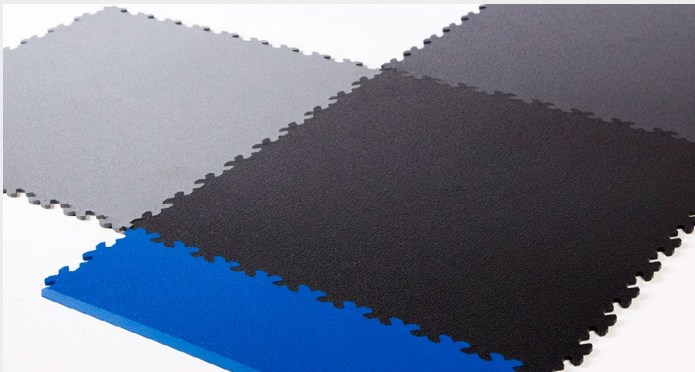
