Job Purpose:

The AEA Aerospace Auditor shall perform audit and training activities on behalf of NQA. The successful candidate will have a successful work history, strong interpersonal and organizational skills with excellent written and oral communication capabilities. Ability to work in a virtual home based environment with extensive travel.

AEA Aerospace Auditors are professionally qualified in accordance with industry and NQA requirements to carry out assessment activities to a spectrum of companies. The role will require extensive travel time / nights away within the India and Overseas thus requiring flexibility in periodic absence from home.

Key Duties and Responsibilities:

- To assess a client's documented management system to ensure compliance with recognized accreditation standards. Including AS9100/ISO9001/AS9110/AS9120.

- To perform management systems assessments and surveillance visits in a timely manner in accordance with the visit schedule. Utilising NQA and third party systems as required (OASIS, EQM)
