



FOCUS & HONESTY

Focus on the Standard & watch out for scope creep

Be clear on what your motivations are

Ensure processes & procedures are correct

Be honest when defining risk & opportunities

Set the objectives you want to meet

Share the positive & the negative

Provide a true representation of the organisation



DUPLICATION & CENTRALISATION

Integrate Systems

Don't keep several copies of the System in different locations

Use the Management System to signpost out across the organisation

Define Roles & Responsibilities

Coordinate Audits and Management Review



COMPLEXITY & LANGUAGE

No need to write like a Standard, use language that will be recognised

Use diagrams

Do the hard work at the start

Involve everyone but only share what is relevant

Don't try and proceduralise everything

Be able to accommodate future growth of the organisation

Consider influence & Risk – it should not put you out of business



AVAILABILITY

All management system tools in one place

Be consistent

Integrated software

Signposts to records and evidence across the organisation






